I. DIRECTOR'S COMMENTS

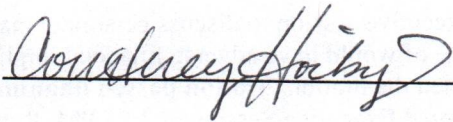
1. **Matt** – Good meeting and glad we are moving forward.
