**I. DIRECTOR'S COMMENTS**

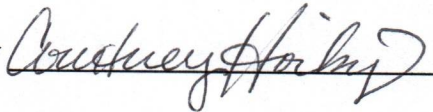
1. **Matt** – Good Meeting and phone is on 24/7. If not, I am able to receive a text.
