*If I terminate service before my contract term ends I will be responsible for payment of the remaining time on my contract. If monthly billing is chosen I must live and have a mailing address in The Bristol Bay Service area.

*Installation fee (\$40.00) not included. Temporary installations will be charged time (\$90.00/hr) and materials.

**In some cases, advance payment of installation fee and one month service may be required.

It is a crime to steal Bay Cablevision's service.

Under Alaska state statutes, theft of a utility service is a Class A misdemeanor. Further, there are civil liabilities if such theft results in damage to a utility's property or equipment.

Bay Cablevision is committed to prosecuting signal thieves.

Beyond criminal and/or civil penalties which may result, signal thieves may also be denied future service by Bay Cablevision.

Everybody pays when one person steals.

Cable TV theft may result in damage to lines carrying service to other customers and a loss of quality in their signal. In such cases, technicians can spend hours checking equipment in response to a customer complaint, or must be sent out to repair line damage. These unnecessary costs increase the price everybody must pay for service.

Report signal theft.

Call Bay Cablevision at 246-3300 if you suspect signal theft may be occurring. By doing so, you'll help keep costs down and quality of service up for everyone.
